Hold Harmless Agreement

Premise Usage Agreement

- Fuel Bootcamp and Yoga LLC is doing business as Fuel Yoga Workouts and does business both on and off the physical premise of 826 SW 2nd Ave, Portland, Oregon 97204. This document applies to activities, instructions, classes and all business associated to Fuel Yoga Workouts both on and off premise.
- I understand and agree that I will be exposed to heat, and/or humidity, and/or artificial fog, and/or artificial smoke, and/or music, and/or other environmental and visual manipulations and consent to this exposure. I hold harmless Fuel Yoga Workouts, its employees, officers, and instructors, shareholders, and contract trainers for any damage or injury of any kind to self or property arising out of my participation in any Fuel Yoga Workouts event or activity.
- I understand that while on the premise of Fuel Yoga Workouts as well as during participation in activities, classes, and events offered by Fuel Yoga Workouts which may be on or off premise I may be photographed and videotaped. I consent to such photography. I release all rights to such photography. I grant Fuel Yoga Workouts the right to use these images and video at their discretion. I expect no compensation, royalties, payments financial or otherwise for the use of such photography.
- I authorize Fuel Yoga Workouts, its assigns and transferees to copyright, use and publish the photography in print and/or electronically. I agree that Fuel Yoga Workouts may use such photographs of me and my property with or without my name and for any lawful purpose, including for example such purposes as publicity, illustration, advertising, and Web content.
- I (hereinafter "I" or 'applicant") have been examined by a licensed Physician within the past six months and have been found by such physician to be in good health and fully able to perform all exercises and activities which I am to learn and perform during my enrollment or visits with Fuel Bootcamp and Yoga (doing business as Fuel Yoga Workouts).
- I will faithfully follow all instructions given to me by Fuel Yoga Workouts instructors as to when, and how to perform and not to perform exercises and activities. I understand that group exercise activities may expose me to risk of personal injury, disease, or death and I knowingly and willingly assume such risk.
- I understand and agree that I will receive instruction in exercise and that I hold harmless Fuel Yoga Workouts, its employees, officers, and instructors, shareholders, and contract trainers for any damage to or theft of personal property on or away from Fuel Yoga Workouts' premises, or personal injury, including but not limited to bodily injury. disease, disability, death, humiliation, or consequential loss of any kind arising out of my participation in any Fuel Yoga Workouts event or activity.
- In the event that I am pregnant, I will not attend a class until I have discussed the potential risks to me or my unborn child/fetus with my obstetrician. I agree that I will follow my obstetrician's recommendations and on behalf of myself, my heirs, spouse or other interested party hold harmless Fuel Yoga Workouts for any possible injury to myself or my unborn child/fetus.
- If I am under 18 years of age, I warrant that I have disclosed my age to Fuel Yoga Workouts and in addition to my signature, have provided the signature of my parent or legal custodian or guardian below.
- Registration and Tuition for classes paid hereafter are non-refundable.
- I understand and agree that if I do not arrive at least 5 minutes prior to a class or event my reservation may be forfeited without refund and I may be charged a cancellation fee.
- I agree that the information I provide is true and accurate and may be used to by Fuel Yoga Workouts to update me about changes in policies, terms and conditions.
- Any provision not in conformity with the law of any state or governing body having jurisdiction is hereby severed from this contract and the remaining provisions remain enforceable. Applicant agrees that any dispute regarding this Agreement will first be tendered by the parties to a member of The American Arbitration Association for resolution prior to the filing of any lawsuit. Applicant also agrees, failing a successful arbitration effort, any suit to be tendered will be filed in and under the laws of the State of Oregon.
